

End-User License Agreement ("EULA") of Mint Medical GmbH/Mint Medical, Inc. (Mint Medical)

IMPORTANT-READ CAREFULLY: This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Mint Medical for the Mint Medical software that accompanies this EULA, which includes computer software and may include associated media, printed materials, "online" or electronic documentation, and Internet-based services ("Software"). An amendment or addendum to this EULA may accompany the software. YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA BY INSTALLING, COPYING, OR OTHERWISE USING THE SOFTWARE. IF YOU DO NOT AGREE, DO NOT INSTALL, COPY, OR USE THE SOFTWARE; YOU MAY RETURN IT TO YOUR PLACE OF PURCHASE FOR A FULL REFUND, IF APPLICABLE.

1. GRANT OF LICENSE.

Mint Medical grants you the following rights provided that you comply with all terms and conditions of this EULA:

1.1 Installation and use. You may install, use, access, display and run one copy/copies of the Software on a single or multiple computers with respect to the kind of license you obtained from Mint Medical. Accessing the software remotely (i.e. by means of Remote Desktop or others) is explicitly permitted ONLY for network licenses.

2. RESERVATION OF RIGHTS AND OWNERSHIP.

Mint Medical reserves all rights not expressly granted to you in this EULA. The Software is protected by copyright and other intellectual property laws and treaties. Mint Medical or its suppliers own the title, copyright, and other intellectual property rights in the Software. The Software is licensed, not sold.

3. LIMITATIONS ON REVERSE ENGINEERING, DECOMPIATION, AND DISASSEMBLY.

You may not reverse engineer, decompile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

4. NO RENTAL/COMMERCIAL HOSTING.

You may not rent, lease, lend or provide commercial hosting services with the Software.

5. CONSENT TO USE OF DATA.

You agree that Mint Medical and its affiliates may collect and use technical information gathered as part of the product support services provided to you, if any, related to the Software. Mint Medical may use this information solely to improve our products or to provide customized services or technologies to you and will not disclose this information in a form that personally identifies you.

6. LINKS TO THIRD PARTY SITES.

You may link to third party sites through the use of the Software. 8. UPGRADES.

To use Software identified as an upgrade, you must first be licensed for the software identified by Mint Medical as eligible for the upgrade. After upgrading, you may no longer use the software that formed the basis for your upgrade eligibility.

9. NOT FOR RESALE SOFTWARE.

10. EXPORT RESTRICTIONS.

You acknowledge that the Software is subject to German export jurisdiction. 11. SOFTWARE TRANSFER.

Internal. You may move the Software to a different Workstation Computer. For this purpose, you will have to request an updated license file from Mint Medical.

12. TERMINATION.

Without prejudice to any other rights, Mint Medical may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Software and all of its component parts.

13. EXCLUSION OF INCIDENTAL, CONSEQUENTIAL AND CERTAIN OTHER DAMAGES.
